SUMMARY

Offer Price and Use of Net Proceeds from the Share Offer

- The Offer Price has been determined at HK\$0.34 per Offer Share exclusive of brokerage of 1%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%.
- Based on the Offer Price of HK\$0.34 per Offer Share, the net proceeds from the issue of Offer Shares under the Share Offer are estimated to be approximately HK\$29.4 million, after deducting related underwriting commission and estimated expenses in connection with the Share Offer. The Company intends to apply such net proceeds for the purposes as set out in the section headed “Business Objective and Use of Proceeds” in the Prospectus.

Applications Under the Public Offer

- The Offer Shares initially offered under the Public Offer have been significantly over-subscribed. A total of 7,896 valid applications pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms and by giving **electronic application instructions** to HKSCC via CCASS for a total of 1,241,650,000 Public Offer Shares were received, representing approximately 82.8 times of the total number of 15,000,000 Public Offer Shares initially available for subscription under the Public Offer. Accordingly, the reallocation of the Offer Shares as described in the section headed “Structure and Conditions of the Share Offer” in the Prospectus has been applied, and the final number of the Public Offer Shares is 60,000,000 Shares, representing 40% of the total number of the Offer Shares available under the Share Offer.
